Applications are invited up-to 13th September 2017 for appointment to the post of "Technician-C" as detailed below:-

Technician-C (OBC) - One Post

Pay of Rs.29,200/- at level 05, in the Pay Matrix under CCS Pay Rules, 2016.

Qualification & Experience:

10+2 with Science subjects from a recognized board with one year Diploma in Medical Laboratory Technology (DMLT) from Govt. recognized Organization/Institutes/Medical College and One year experience in recognized Institute.

Or

10+2 with Science subjects with two years Diploma in Medical Laboratory Technology (DMLT).

Age Limit:-

- i) Not exceeding 30 years- Relaxation will be allowed for OBC as per GOI rules. Government servant/in service candidates will be allowed 5 years relaxation, OBC, Ex-Servicemen and PWDs will be allowed relaxation as per GOI rules applicable from time to time.
- ii) OBC candidates are required to submit the caste certificate as per GOI rules/ instructions latest by 3 years old from the date of publication of this notification and issued by competent authority in the prescribed format. "Form of certificates to be produced by other backward classes applying for appointment to post under the Government of India."
- iii) Candidates working/have worked on long term Projects in ICMR or in ICMR Institutes/Centres will be given "One time" age relaxation.

How to Apply:

Candidates who wish to apply for the post may submit their applications on a plain paper along with detailed bio-data, attested copies of certificates/testimonials, age, caste, experience etc. along-with a Demand draft for Rs.100/- (PWDs candidates/women candidates are exempted) drawn in favour of Director, RMRC, Port Blair addressed to the Director, Regional Medical Research Centre (ICMR), Post Bag No. 13, Port Blair 744101 on or before the closing date of submission of application as indicated above. Applications which are incomplete/late/without DD will not be entertained.

General Instructions:

1. Allowances as per Central Govt. rules are admissible. Benefits of new restructured defined contributory Pension system are admissible as per the provision contained in the Ministry of Finance, Department of

3. Only short-listed candidates will be called for written test. The date, time and place of written test will be intimated separately.
