1. The service provider should have an in-house Illumina platform (ex: NovaSeq 6000 or HiSeq) and PacBio Sequel II facility located in India. A valid installation certificate is mandatory. Proposals without this document will be technically disqualified.
2. The analysis must be performed by PhD- and Postdoctoral-level experts with a minimum of 5 years of experience in genome assembly and annotation. Relevant profiles must be submitted as proof.
3. The service provider should present a certificate guaranteeing that all sample processing and sequencing will be exclusively carried out within the borders of India as per India's Biodiversity Act.
4. Photographic documentation of the facility showcasing the presence of Megaruptor-3, FemtoPulse, BluePippin, PacBio Sequel II, and Illumina NovaSeq 6000 is mandatory.
5. The service provider must provide a valid ISO certificate as a mandatory requirement.
6. The service provider should possess a valid Department of Scientific and Industrial Research (DSIR) certification for their Indian laboratory as a mandatory requirement.
7. Service providers with documented prior experience in whole genomes sequencing, evidenced by purchase orders (POs) from similar projects undertaken during the last 5-8 years, will be given preference.
8. The service provider must submit at least 10 purchase orders from the last four years demonstrating experience with PacBio Sequel II, genome assembly, Hi-C sequencing, and Iso-Seq sequencing of eukaryotic genomes.
9. Service providers with a minimum of 5-10 years of experience in the field of genomics and sequencing services will be preferred.
10. The indenter should be able to visit the vendor at any point of time to monitor the workflow.
11. Service provider shall provide hands-on training for a period of one week, covering the complete workflow of Illumina NovaSeq 6000 sequencing, PacBio Sequel II and bioinformatics data analysis to two designated personnel from ICMR-RMRC, Sri VijayaPuram. The training shall cover key steps in sample processing, sequencing workflow and quality control. Training must be provided at the beginning of the sample submission process, specifically within the first two batches of sample submissions.
12. Payment will be made in batches based on sample submission and processing.
13. In case of any failure in sample processing/data output, it will be redone at no additional cost.
14. The data shall not be stored, deposited, or shared with anyone else, and is the exclusive property of ICMR-RMRC, Sri VijayaPuram.
15. An additional 5-10% of samples may be accepted for processing at the same fixed rate as that applied for the initial 30 samples submitted for sequencing.
16. The service provider must provide CA-certified documents showing revenue, profit, and income tax returns for the last three years (FY 2024-25, FY 2023-24 and 2022-23). The company should be financially viable and must not have incurred any losses during these financial years.
17. The service provider must be an Indian company with over 51% ownership by Indian citizens. A shareholder certificate must be provided.
18. The bidder must be financially solvent and must not be involved in any bankruptcy or insolvency proceedings. Bidders undergoing or having undergone insolvency within the last three financial years (FY 2022-23, 2023-24, and 2024-25) shall be deemed ineligible to participate in this tender.

24. Raw data should be trimmed and a contamination check should be done to remove adapter sequences and errors. Raw data and analysis data should be submitted via HDD.

27. The cost submitted should encompass data submission to the NCBI database.

29. On-site Bioinformatics training should be provided for 1 week

32. Penalty clause:

If data does not fulfill the all above detailed criteria, the data will not be accepted and payment will not be made and order will be cancelled. If timely delivery of data is not done, penalty will be applied. In case of late delivery of raw data 0.01% of total cost will be deducted for delay of every day and delay of more than 30 days will be lead to the cancellation of the order. If the Vendor does not follow the above mentioned detailed criteria, the institute/ Lab has the full right to cancel the order at any time. In that case, no payment would be made.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
