- 3. Certificate of recognition/approval given by Distance Education Council, IGNOU in case the degree awarded to you is by means of Distance Education. Such of those candidates who have acquired their Degree through Distance Education mode, which is not recognized by Distance Education Council, IGNOU shall not be allowed to appear for the Interview.
- 4. Employees of Govt Departments shall bring necessary proof of the employment for claiming age relaxation. Please note that you will not be eligible for being treated as a Departmental Candidate if you have ceased to be in Service;
